## From Our Commander

#### THE KINGDOM OF CALLAWAY

On October 27, 1861, the United States recognized Callaway County, Mo., as an independent region.

Though Confederate in sympathy, Callawy County had not yet rebelled against the Union when Col. T.J.C. Fagg assembled 500 militiamen nearby to hunt for Callaway's supposed "nest of Reb sympathizers." In reaction Callaway's eccentric Col. Jefferson Jones recruited 300 volunteers—mostly old men and boys—and positioned them near the county border. Their weapons included a fake cannon of wood painted black.

Colonel Fagg, unaware of the weakness of the opposition, stopped his advance three miles from the county line. Colonel Jones then sent negotiators under a flag of truce to Fagg's superior, Gen. John B. Henderson, stating that the Callaway "army" was committed to resistance. A treaty was signed, with each side promising not to invade the other.

In treating Callaway County with equality, the U.S. virtually gave it independent status, and it became known as the "Kingdom of Callaway."

# Company A, 49<sup>th</sup> Iowa Volunteer Infantry The Iowa Rifles

"THE GOVERNOR'S OWN"

Co. A, 49th Iowa Volunteer Infantry, has had a very busy second quarter.

On June 5 several members attended the Des Moines Farmers' Market for a "meet-and-greet" and fund-raiser for our monument-restoration fund. The outing was a great success. That evening, the Regiment held its first-annual "birthday party". The weather, however forced the party inside. Nevertheless, the event was a marked success.

The Regiment received, and accepted an invitation to attend Cornerstone Family Church, in Des Moines on June 6th to recreate the "Juneteenth" proclamation of 1864, also known as 'General Order #3', or The Emancipation Proclamation at two services. The congre-gation of several hundred persons of mostly African descent, paid rapt attention to the brief reading of the four-sentence document by First Sgt. Lamb. "Juneteenth" is the combination of the words June nineteenth, the day the proclamation was read at Galveston, Texas by General Granger.

On June 12<sup>th</sup>, several members and their wives traveled to Muscatine, IA, to attend a fund-raising event to restore the Civil War monument there. The current monument, a badly-eroded white marble statue and a series of plaques listing local Civil War veterans around the base. The Regiment presented a check for \$500 to Mr. Lee Miller to assist with the project which will cost approximately \$400,000. The statue is to be replaced and a further 60+ names will be added to the plaques. Despite the rain that plagued the event, it was deemed a success. The monument is tentatively scheduled to be re-dedicated on July 4, 2010.

The celebration commemorating the Centennial of the Des Moines City Hall was the next Regimental event. Seven members, accompanied by wives and members of the Allied Orders were present. The Regiment's newest member, Frank Hanna, is the great-nephew of Mayor James Hanna, the man who presided over the building's dedication in 1910. Also present was Sister Eleanora McConley, who was born just a few weeks after the building's dedication.

On June 19<sup>th</sup> four members of the "Governor's Own" traveled to Lehigh, Iowa for their town celebration. Activities included a display table and participating in the parade.

Eight members of the "Governor's Own" participated in the Redfield, Iowa town celebration on June 25. Activities included the parade, a flag disposal ceremony, and a display table. The latter was located in front of the recently restored GAR hall.

The weekend of July 3-4 was very busy. On the 3<sup>rd</sup>, five members participated in the Urbandale, Iowa Independence Day parade. Four members assisted in carrying a 12-foot by 18-foot 34-star American flag. The fifth member carried the regimental colors. On July 4<sup>th</sup>, eight members took part in the rededication of the newly restored Grant Wood stained glass window in Cedar Rapids. Damaged by the severe flooding of 2009, this masterpiece has six life size soldiers depicted in the 3-story high panels. The six soldiers depicted represent the Revolutionary War, the War of 1812, the Mexican War, the Civil War, the Spanish-American War and World War I.

On July 16th, Governor Chester Culver presented the 'Governor's Volunteer Recognition Award' to Co. A, 49th Iowa, SVR in recognition of efforts made in assisting the Battle Flag Restoration project. The award was accepted by 1st Sgt. David Lamb, commanding officer of the Regiment. Pvt. David Thompson received an individual award for his participation in the Battle Flag restoration lab. Both awards came from nominations by Sheila Hanke, Chief Conservator in the museum's laboratory.

Five Guardsmen and three of the Regiment's "Ladies" spent several hours doing a 'meet and greet' at the Des Moines downtown farmers' market on July 24th. Several thousand people stopped by and a great deal of literature was given out. The next day, July 25th, Dahl's Supermarket at 18th and Ingersoll was the scene of a 4-hour "meet and greet" that netted \$172.00 for our Monument Restoration fund.

Six members of the Regiment attended the National Encampment of the SUVCW in Overland Park, KS A On Aug. 16th, seven members participated in the annual parade at the Iowa State Fair.

Rounding out this quarter's list of activities on Aug. 28<sup>th</sup> was another 'meet and greet' at another of the Dahl's grocery stores in Des Moines. We added \$126.00 to our treasury thanks to the generosity of the passers-by. Five members of the Regiment attended accompanied by their ladies.

#### "The Governor's Own" Receives Governor's Volunteerism Award 16 July 2010

In ceremonies held today at the newly completed FFA Enrichment Center on the Ankeny Campus of the Des Moines Area Community College, The Honorable Chester Culver, Governor of the State of Iowa, awarded his "Governor's Volunteer Recognition Awards for 2010" to the Guardsmen of Company "A" 49th Regiment Iowa Veteran Volunteer Infantry.

Today's ceremonies honoring volunteerism in Iowa marks the twenty-seventh year that such awards have been given; and, Governor Culver in his remarks before handing out the awards, informed all present that only the state of Utah can boast a higher percentage of it's populace that is involved in some sort of volunteer activities. He said that volunteerism in Iowa is engaged in by just over 40% of the population of the state.

The regiment's award, recommended by Mrs. Sheila Hanke, Conservator for the Iowa Battle Flags Project of the State Historical Society of Iowa, is given in recognition of the participation of members of the unit in the moving of Iowa Battle Flags onto and off of public display at the Iowa Historical Museum and the Iowa State Capital Buildings in Des Moines. The unit assumed these duties in September of 2009 when it became apparent that funding for the moving of the flags would not be available.

Through that involvement, Color Sergeant David Thompson (who received an individual award at today's ceremonies); and, then First Sergeant Lamb became part of the permanent volunteer staff in the Conservation Laboratory and each embarked upon the two-hundred hour on-the-job training program under Mrs. Hanke' very capable oversight to become Volunteer Conservators for the project. Also supervising the volunteers in their efforts is Assistant Conservator Sarah Carlson who could not attend today's ceremonies because she is preparing to take part in a Summer Internship through her Master's program in London, England.

Thompson and Lamb would soon be joined on the project by Sister Mary Rittel (Grenville M. Dodge Camp Auxiliary member, and wife of Corporal Dan Rittel) who is doing much needed seamstress work for the project; and by Corporal Louis A. Zenti, who will be constructing the metal frameworks that the flags rest upon when placed upon public display.

Shown in the accompanying photographs are the actual certificate of award from the Governor; the Governor's Volunteer Award pin that will henceforth become a part of the Dress Uniform of the 49th Iowa; and, a photograph of those present to receive the honor on behalf of the Regiment.

Governor Culver told us that he has some two-hundred and thirty some letters written during the Civil War by his Great-grandfather to his great-grandmother and that he and his wife are in the process of planning a trip to visit all of the places that his ancestor fought with his Illinois Regiment over the course of the war. I respectfully suggested to the Governor that he needed to belong to the Department of Iowa, SUVCW. At that, he took my business card and promised that he would, "be in touch". Governor Culver was made Honorary Colonel-In-Chief of the 49th Iowa in February of this year when he signed the proclamation officially naming us to be "The Governor's Own Iowa".

The 47th Missouri Infantry, Company E - SVR has been busy with several events lately. First, we participated in the Lt. Col. Felix St. James Camp 326's Civil War encampment in Ste. Genevieve, MO on Saturday, July 10,

2010. During this event we did drills and demonstrations for the public. Later that day we participated in the reenactment of the 1861 appropriation of funds from the local bank and captured two southern sympathizers as well.

Next, we were hosting a gravestone dedication ceremony for 1SGT Robert M. Womack of Company F, 50th Missouri Infantry. This veteran served in the Battle of Pilot Knob and later had the town of Womack, MO named for him (here he is buried). This ceremony turned out wonderfully and the 47th Missouri Infantry, Company E - SVR was graciously assisted by the 78th Enrolled Missouri Militia, Co. F - SVR, and a member from the 2nd Missouri Infantry, Co. A - SVR. This also was coupled with a magazine reporter wanting to do a special article on our group, which was followed up by a small photo shoot and article for the "Insider 573" magazine (September 2010 edition).

Then, on Saturday, July 24, 2010, members of the 2nd Missouri Infantry, Co. A - SVR held two ceremonies honoring Ulysses S. Grant. One was held at the Ulysses S. Grant National Historic Site (Whitehaven) in St. Louis and the other was in Ironton, MO. We assisted with the celebration in Ironton, on the spot where Grant received his Brigadier General's commission in 1861. The local newspaper ("The Mountain Echo") printed an article on this ceremony the following Wednesday on its front page.



Finally, we come to our latest activity which was the Valles Mines History Day on August 7, 2010. This event was a last minute one, but we were able to get four of our guys and two of the Louisa Volker Auxiliary 215 to participate. We dressed in our uniforms and period attire, fired various Civil War weapons, and demonstrated what an infantry soldier may have carried in our area. The crowds loved it and it benefited our groups as well, as one family is joining the Auxiliary and the Sons. This was furthered by news reporters and a photographer from the "Jefferson County Leader" which assured us that this would be in the paper.

In conclusion, our unit is gearing up for even more activities throughout September, October, and November, like a Civil War Fashion Show & Educational Activity at St. Francois State Park (near Bonne Terre, MO) and the Pilot Knob, MO reenactment. We hope to give the local communities a better understanding of what our ancestors did and to promote the SVR and SUVCW.



## Quote From the Past

## The Ste. Genevieve Bank Seizure From another Perspective

"The town of St. Genevieve was surrounded by a military force during the night of the 15th of August 1861, by a battalion of Zouaves, commanded by Major John McDonald, since notorious for his trial before United States courts. After seizing the bank he took military possession of the town. The next day he demanded of the president, Firmin A. Rozier, of the branch bank of the Merchant's Bank of St. Louis, located here, the funds of the bank. After some parley the president delivered them under protest, and upon the condition to accompany the battalion to St. Louis on the steamer Hannibal. The Major had come for the money, and kept his eye steadily on his gun, insisting on a peaceable surrender. The money, a large amount, was taken on the steamer, having on board Mr. Rozier, the Major and the battalion of Zouaves. On arriving in St. Louis Mr. Rozier called at headquarters to see General Fremont, for an interview, who that day handed Mayor Howe an order to be delivered to Mr. Rozier for the funds of the bank, which were deposited with Colonel Robert Campbell, president of the Merchants Bank."
